### **CANDIDATE STATEMENTS**

## Michaela Boryslawskyj, University Secretary, Sheffield Hallam University

I am delighted to be considered for the post of nationally elected member of the AHUA executive, having been an active member of AHUA since 2014, when I became University Secretary at the University of Huddersfield, and continuing my membership when I moved to Sheffield Hallam University in 2019. I believe my skills (particularly my grounding in legal, regulatory, governance and compliance matters) combined with my experience at two very different post-92 universities and my personal commitment to the importance of widening participation would enable me to make a valuable contribution as a member of executive.



I have benefitted from a hugely rewarding career in higher education over the past 14 years, which started with a focus on leading the in-house legal and information governance provision and broadened to encompass all aspects of governance, legal and regulatory compliance; which feels like an increasingly important part of university life and a key strategic enabler in supporting the success of institutions.

AHUA occupies an important space, ensuring effective representation on key issues and policies to the OfS, government and other key stakeholders. This is needed more than ever as we continue to respond to the various and intensifying regulatory and legislative demands, in an increasingly volatile and financially constrained environment. I'd like to support the Association to continue this expert advocacy on behalf of its members, being passionate to contribute in particular to the consideration of ongoing legal matters, including proposals for a statutory duty of care, Martyn's Law and the implementation of Freedom of Speech (Higher Education) Act 2023.
